I agree that the equipment will be used for purpose of snowboarding at Nordic Mountain only. I agree there are no warranties, expressed or implied, which have been made to me concerning the snowboard equipment, and I accept the snowboard equipment in its AS IS condition.

**I, the undersigned, in consideration of the rental of the equipment by Nordic Mountain, LLC hereby RELEASE AND FULLY DISCHARGE Nordic Mountain, LLC, its owners, agents, and employees from any and all liability resulting from personal injury to myself or damage to my property which is caused in any way by the NEGLIGENCE of Nordic Mountain, LLC or any of its owners, agents, or employees in the installation, adjustment, inspection, maintenance and/or rental of the equipment, and/or in the instructions given or not given to me concerning the equipment and its use, and/or from my use of this equipment.** I accept full responsibility for any and all injuries or damages of any kind which may result from the use of the snowboard equipment and it is my intention to HOLD Nordic Mountain, LLC, its owners, agents, and employees HARMLESS for any injury sustained by me while using the above described snowboard equipment.
